**ACT OF ACCESSION TO THE CONVENTION FOR THE PACIFIC SETTLEMENT  
OF INTERNATIONAL DISPUTES**


**WHEREAS**, the Convention for the Pacific Settlement of International Disputes (hereinafter referred to as “the Convention”) was concluded at The Hague on October 18, 1907,

**AND WHEREAS**, the Government of the Republic of Kosovo has decided that the Republic of Kosovo shall become a Party to the Convention.

**NOW THEREFORE**, the Government of the Republic of Kosovo having considered the Convention for the Pacific Settlement of International Disputes, concluded at The Hague on October 18, 1907, declares hereby that the Republic of Kosovo accedes to the Convention and undertakes to carry out faithfully the provisions therein contained.

**IN WITNESS WHEREOF**, I, Hashim Thaçi, Deputy Prime Minister and Minister of Foreign Affairs of the Republic of Kosovo, have signed this Act of Accession.
